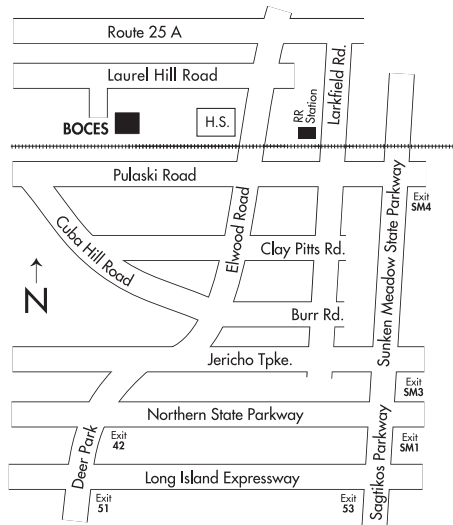

What is a Surgical Technologist?

A Surgical Technologist works closely with the surgeon, anesthesiologist and registered nurse to set up and assist in all types of surgical procedures.

Employment Opportunities

Surgical Technologists are employed in the operating room, surgical office, delivery room, emergency departments, physician and dentist offices, central supply services, cardiac catheterization clinics, tissue banks and ambulatory surgical care sites.

How do I apply?

1. Register and take the pre-entrance examination. This examination is given several times each

year at BOCES' Northport facility. Call 261-3721, x245 for the registration form. A registration fee of \$100 (non-refundable) must accompany your registration form and must be paid by money order payable to Western Suffolk BOCES. If you have a current IEP and are requesting testing modifications, call 631/261-3721

2. Complete and return the application packet which will be sent to you following satisfactory achievement on the pre-entrance examination.
3. A personal interview will be scheduled after each applicant has passed the pre-entrance exam and submitted a complete application packet.

What are the requirements for admission?

- Satisfactory achievement (must score above the 40th percentile in Math and Reading on the standardized pre-entrance exam)
- Completed application form
- High school diploma or equivalency
- Good physical and mental health
- 20/20, 20/30 vision with/without corrective lenses in both eyes
- Ability to stand for lengthy periods
- Three references. Two must be work references; one must be a character reference.
- Personal interview

The School of Surgical Technology reserves the right to deny admission based upon failure to complete admission requirements. Enrollment is limited to 10 students per class.

Financial Information

Tuition: \$14,499 (subject to change). Additional costs include textbooks, malpractice insurance (nominal fee), CPR certification, AST membership, a physical exam and uniforms. Installment payment plan and financial aid are available for those who qualify.
